"Competent authority has approved following for further extension for empanelment of QCI, which is carrying out sampling activities at loading end :-

1. The extension of empanelment of QCI shall be at the existing terms and conditions at the market discovered price in PFC tender @Rs2.97 per tonne. Thus, the same shall be applicable to Power sector and Non-Power sector consumers
2. The validity of empanelment of QCI shall be till 25-05-2027.
3. The revised rate of sampling activity for the existing tripartite agreements with QCI shall be applicable w.e.f. 08-11-2023 i.e. from the date of communication of revised rate by PFCL to CIL.
4. Further, QCI shall be allowed to enter into new tripartite agreement(s) during the extended empanelment period with the willing power utilities and Non-Power sector consumers at the loading end.

Accordingly, consumers having valid tripartite agreements with QCI as on 25.11.2023 may extend the same further till the validity of FSA/validity of empanelment (as the case may be) with the revised rate notified by CIL as above and with the existing terms and conditions of the tripartite agreement for sampling continuity, if desired.

For such extension if desired by the consumer, such consumer shall sign a side agreement for such extension with the existing terms and conditions of the tripartite agreement on or before 21.11.2023 positively.
