- In case of NIT published after 06.01.2017 but before 27.12.2017, carrying provision under Clause 4.2(ii) relating to the associated, all individuals/firms/companies/associated/JV who were persons as defined in Section 40(A)(2)(b) of the Income Tax Act, 1961 related to any debarred party and were considered as debarred shall be freed from such debar subject to fulfilment of any of the following conditions:
