

\* In case of NITs published after 06.01.2017 but before 27.12.2017, carrying provision under Clause 4.2(ii) relating to the associates, all individuals/firms/companies/associates/JV who were persons as defined in Section 40(A)(2)(b) of the Income Tax Act, 1961 related to any debarred party and were considered as debarred shall be freed from such debar subject to fulfillment of any of the following conditions-

- (i) The Associate entity never had any business dealings with CCL, or
- (ii) The Associate entity had business dealings with CCL after 06.01.2017 but there is nothing adverse on records that entail debarring.

The associates should submit their documents to GM(CMC) to prove that they fulfil the above conditions. On submission of documents, they will be verified by GM(CMC) and on verification, if their claims are found justified, their debarment shall be lifted for future with the approval of Competent Authority of CCL.
