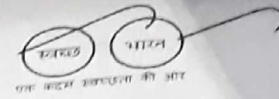

On being released from their present place of posting the above named employees will report to the General Manager/HOD of the selected place of posting to the selected post for the further assignments.


They will be on probation of 06 months as per the clause 3.6 of Certified Standing Orders of the company.
