### ORDER FOR BANNING OF BUSINESS

An NIT bearing no:- G.M.(M-S)/S.O.(E&M)/e-NIT/21-22/01 dated:- 20.05.2021, Tender ID:- 2021\_CCL\_206673\_1 for the work related "Hiring of 03 Nos. hard top closed jeep (Bolero or equivalent), LMV, Diesel version on 24 hrs. basis for 03 years for Magadh Project, Magadh- Sanghmitra Area" was floated on CIL e- Procurement Portal

After opening of price bid on schedule date & time M/s Vijay Kumar Mahto, Hazaribagh was found L2 bidder. The L-1 bidder i.e. M/s Samarun Nisha has been rejected as per clause 14.K. Moreover, as per clause no. 14.2.G the technical Evaluation of documents uploaded by the original L-2 bidder now becomes L-1 Bidder i.e M/s Vijay Kumar Mahto, Hazaribagh was done as per NITT and some deficiency was requested online to upload required shortfall documents within in schedule time from 21.06.2021 at 10.00 A.M. to 28.06.2021 at 05.00 P.M. (07 Days) on e-portal of coal India limited as per clause no. 14.B of the e-NIT. M/s Vijay Kumar Mahto, Hazaribagh has not uploaded the required shortfall documents within the schedule time period.

As per clause no. 14.E of the e-NIT which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected and **the bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal"**
