ORDER FOR BANNING OF BUSINESS

An NIT bearing no:- S.O.(E&M)/e-NIT/19-20/31 dated:- 02.12.2019 , Tender ID:- 2019_CCL_157525_1 for the work related "the work of Hiring of 02 no. Of Hard top closed Ambulance(TATA sumo or equivalent) version having good suspension for a period of 05 years on 24 hrs. basis for CSR Dispensaries, at Ursu village of Amrapali OCP(01) & Masilong village of Magadh OCP(01) Magadh Amrapali Area under CSR." was floated on CIL e- Procurement Portal

After opening of price bid on schedule date & time M/s Vikash Kumar Chourasia was found L-1 bidder. Moreover, technical Evaluation of documents uploaded by the L-1 bidder i.e M/s Vikash Kumar Chourasia, Garilong,Tandwa, Chatra was done as per NIT. After observing necessary formalities/evaluation M/S Vikash Kr Chourasia, Tandwa, Chatra was issued award of work vide no. SO(EnM)/MA/WO/20-21/16 dated 18.06.202 The party had provided the said vehicles on dated 25.06.2020 and performance security money on the given time period. On dated 01.10.2020 one no. Of Ambulance bearing reg no. JH03Y 2752 engine had been seized, and this was absent in duties and on dated 21.10.2020 the 2nd ambulance bearing reg. No JH03 AA 7456 was also found absent in duties. Reminder had been given to the firm regarding the deployment of Ambulances. one reminder vide . SO(EnM)/MA/letter/20-21/386A dated 20.10.2020, for vehicle reg no. JH03Y 2752 and one reminder vide . SO(EnM)/MA/letter/20-21/345A dated 01.10.2020, for vehicle reg no. JH03 AA 7456 . One dated 01.10.2020 for JH03 AA 7456 and on dated 21.10.2020 for JH03Y 2752 we have received two letters from M/S Vikash Kr. Chourasia in which he was explained that he will be unable to provide the vehicles.

As per clause no 5.1 of "GTC" "If the contractor, without reasonable cause or valid reasons, commits default in commencing the work within the aforesaid time limit, the company shall, without prejudice to any other right or remedy, be at liberty, by giving 15 day's notice in writing to the contractor to commence the work, failing which to forfeit the Earnest Money deposited by him and to rescind the Letter of Acceptance of Tender/Work Order and also to debar the contractor to take part in the future re-tender"

Under the facts and circumstances mentioned above, as per clause no. 5.1 , under Tender Evaluation of the NIT the business in the name and M/s Vikash Kumar Chourasia, Garilong,Tandwa, Chatra Distt:- Chatra, Id:- Nil, PAN No:- AJKPC4214F & GSTIN No:- NIL is hereby banned for 12 months from eligible to submit bid in CIL and its subsidiaries with immediate effect.
