ORDER FOR BANNING OF BUSINESS

An NIT bearing Ref. No. CCL/CHR/Admin/e-NIT/21-22/01; Dated: 25.06.2021, Tender ID: 2021_CCL_210108_1 was floated on CIL e-Procurement Portal for the work titled "Hiring of 01 (one) no. hard top covered, Diesel LMV for a period of 03 (Three) years in pool under the control of CMO(I/c) at Central Hospital, Ramgarh".

After opening of price bid on scheduled date & time, **Madan Mohan Singh**, Mahto Tola, Marar, Ward No.- 01, Ramgarh Cantt. (Jharkhand) was found L-1 bidder. Moreover, Technical Evaluation of documents uploaded by L-1 bidder i.e. **Madan Mohan Singh** was done as per NIT and deficiency was found by TC in the uploaded documents. Accordingly, **Madan Mohan Singh** was requested to upload required shortfall documents online within scheduled time from 15.07.2021 at 16.00 PM to 22.07.2021 at 16.00 PM (07 Days) on e-portal of Coal India Limited as per clause no. 14.B of the e-NIT. But the bidder **Madan Mohan Singh** has not uploaded the required shortfall documents with in scheduled time period.

As per clause 14.E of the e-NIT, which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected the bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal."

Under the facts and circumstances mentioned above, as per clause 14.B, C & E under Tender Evaluation of the NIT the business in the name and style **Madan Mohan Singh**, Mahto Tola, Marar, Ward No.- 01, Ramgarh Cantt. (Jharkhand), login id:- singhmm159@gmail.com, PAN:- EHUPS0600F is hereby banned for 02 (Two) years from being eligible to submit bid in CIL and its subsidiaries with immediate effect.
