Sub:- Debarring of M/s Maa Vashnavi Construction for two years from participating in tenders in Central Coalfields Limited (CCL) due to non submission of <u>confirmatory documents</u>.

Dear Sir,

In reference to the above captioned matter this is to inform you the following-

That in response to the above referred e-tender M/s Maa Vashnavi Construction i.e. L-1 bidder not submitted valid confirmatory documents which was required as per NIT. Bidder was asked to submit the shortfall document within 09.11.2021 to 15.11.2021 but the bidder has not responded.

As per clause No. 11(E) of the NIT which is appended below, the company shall ban such defaulting contractor for a period of 02 (two years) from being eligible to submit Bids in CIL and its subsidiaries from the date of issue of such letter.

"In case the L-I bidder fails to submit requisite document online as per NIT or if the information/declaration furnished by L-1 bidder online is found to be wrong by T.C during evaluation of scanned document uploaded by bidder, which changes the eligibility status of the bidder, than his bid shall be rejected and the bidder shall be banned for two years from being eligible to submit bids in CIL and its subsidiaries."

The banning shall be done under the provision of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal.

In case JV/Partnership firm, the banning shall also be applicable to all individual partners of JV/Partnership firm.

In view of the above Clause of NIT, following penalty is hereby imposed on you from the date of issue of this letter.

Debarring of M/s Maa Vashnavi Construction., PAN No. AAVFM9403E for 2 years from participating in tenders in Central Coalfields Limited (CCL).CIL Subsidiaries.
