



Dear Sir,

With reference to above Reference, the award for the work of "Annual Cleaning and Maintenance of the CCL Guest House at Balumath under Rajhara Area for 02 years" and "Annual Cleaning of the GM Office (excluding Sundays) and Guest House at Chandwa under Rajhara Area for 03 years" have been awarded to you and instructed to start the work with effect from 08.12.2021 subject to various stipulations/conditions which were supplementary/complementary to the conditions of the tender documents. The Award of Work is issued to you on 06.12.2021 and you were instructed to deposit the Performance Security deposit till 27.12.2021 as per the following Clause of NIT, 4.2.

J. 12022

4.2 Performance Security should be 3% of contract amount (5 % of contract amount in case of long-term contracts i.e. for a period exceeding 5 years) and should be submitted within 21 days of issuance of LOA by the successful bidder.

In case the successful bidder fails to submit the Performance Security and within the stipulated time then the award of work shall be cancelled.

Additionally, the company shall ban such defaulting contractor for a period of 02 (two years) from being eligible to submit Bids in CIL and its subsidiaries from the date of issue of such letter.

This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal.

Thus, as per above mentioned Clause of NIT 4.2, it results in cancellation of the contracts "Annual Cleaning and Maintenance of the CCL Guest House at Balumath under Rajhara Area for 02 years" and "Annual Cleaning of the GM Office (excluding Sundays) and Guest House at Chandwa under Rajhara Area for 03 years with Tender IDs 2021\_CCL\_218174\_1 and 2021\_CCL\_218020\_1 respectively. Additionally, you will be banned for two years from being eligible to submit Bids in CIL and its Subsidiaries from the date of issuance of such letter. The banning shall be done under the provision of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal. The administrative approval for banning of the contractor has been obtained vide Ref. No. 501 dated 18.01.2022 and 502 dated 18.01.2022.

In view of above competent approval for cancellation of your contracts and online blocking of your firm i.e. Roshan Kumar Jha (PAN: AKTPJ4835H) for the period of two years. The banning shall be done under the provision of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal.
