In reference of above mentioned subject you have submitted online tender which was opened on 18.12.2021 & you were the L-1 bidder comparative statement of part – I (i.e. technical bid) was prepared. The tender committee deliberated on documents submitted by you and found that following shortfalls : (1. Undertaking as per NIT has not been submitted.) Accordingly clarification has been sought from 14.01.2022 to 21.01.2022 for the same & submitted documents was also not as per published NIT.

As per **NIT clause no.11. Tender Evaluation e:** (In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected and the bidder will be banned for two years from being eligible to submit Bids in CIL and its subsidiaries. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal.
