The tender committee deliberated on documents submitted by you and found that (GST has not been submitted) . As per NIT the documents has to submitted in bidder space for which there is no provision for re-cycle of the documents.

As per **Tender Evaluation (e)** (In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected and the bidder will be banned for two years from being eligible to submit Bids in CIL and its subsidiaries.

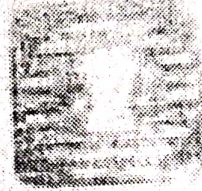
