After Opening of Price Bid on scheduled date & time, M/s MD AFTAB ANSARI, Gandhi Nagar, Sunday Bazar, Dist- Bokaro was found L-1 bidder, Moreover, Technical Evaluation of document uploaded by L-1 Bidder M/s MD AFTAB ANSARI was done as per NIT. Accodingly, M/s MD AFTAB ANSARI was awarded the work vide Ref. No.GM(B&K)/SO(P&P) /Env./Award/21-22/115 Dt 06/12/2021.

As per General terms and Conditions clause No. 6.1 of NIT which states that "If the contractor, without reasonable cause or valid reasons, commits default in commencing the work within the aforesaid time limit, the company shall, without prejudice to any other right or remedy, be at liberty, by giving 15 day's notice in writing to the contractor to commence the work, failing which to to rescind the Letter of Acceptance of Tender/Work Order and also to ban for 02 (two) years from being eligible to submit Bids in CIL and its subsidiaries from the date of issue of such letter. The bidder will also be banned from participating in re-tender. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal." The 15 days Notice was issued vide letter no. GM(B&K)/SO(P&P)/Env./21-22/175 dt 01/03/2022, and the contractor has not commenced the work till date.

Under the facts and circumstances mentioned above, as per General terms and Conditions clause No. 6.1 of NIT M/s MD AFTAB ANSARI, Login id. aftabansari8425@gmail.com .PAN No BTDPA5209E, is hereby banned for 02 (two) year from being eligible to submit bid in CIL and its subsidiary with immediate effect.
