In reference to the above captioned matter this is to inform you the following:

1. That in response to the above referred e-Tender, R.D. Construction has submitted online tender offer on 19.10.2020 in the (e-procurement portal of Central Coalfields Limited (e-procurement portal of Coal India Limited, <https://coalindiatenders.nic.in>) and become L1 bidder.
2. That the L1 bidder has not furnished Performance Deposit & relevant papers for execution of agreement within stipulated period as per ACW.

As per clause 4.2 of NIT, as follows:

Quote :

"In case the successful bidder fails to submit the Performance Security and Additional Performance Security, if any, within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security/earnest money.
