Dear Sir,

You have been awarded with the work of "Construction of PQC CT Road from Manwatongri to WB No. 08 & 09 junction under Amrapali OCP of Amrapali - Chandragupta Area", vide Award of work no. GM(C)/2291/A&C/2021-22/684 Dated 18-12-2021. As per Sl. No. 3 & 28 of award of work, you had to submit the Performance Security Deposit (PSD) amounting to ₹41,15,223/- (Rupees Forty-one lakh fifteen thousand two hundred twenty-three) within 21 days of issuance of award of work. But you failed to submit the requisite PSD amount within stipulated time. Also, you have not taken any action to commence the work.

Your response vide letter no RBS/21-22/0203 dated 24-01-2022 sent through e-mail with respect to letter no GM(C)/2021-22/781 dated 22-01-2022 to site your reason for non-submission of PSD, in which you stated that execution of work is possible only when the rate of item no 1.01 of BOQ is increased from ₹200 to ₹2000. This is not acceptable to the Company, as it is beyond the scope of the NIT.
