Sub: Notice regarding banning of your firm as per amended clause no. 7 of Part - D under Sec - II (ITB) of NIT ref. CCL/CM(P)/HEMM/Vacuum Contactor/EKG/116/RT/2020, read along with corrigendum to NIT Dt. 28.11.2020, opened on 19.12.2020.

Dear Sir,

Upon scrutiny, your offer has found to be technically not acceptable as per NIT terms & conditions for the tendered item for which you emerged as single bidder in the subject tender and your firm is a defaulter for the above subject tender.

Please refer corrigendum to Clause No. 2 (Section-I, IFB) and Clause No. 7 (Part-D, Section-II, ITB) of NIT which states that:

"Bidders shall have to sign a Bid Securing Declaration accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline or any other default which attracts forfeiture of EMD (as prescribed in existing manuals/NIT) as defined in the request for bids document, they will be banned for two years from being eligible to submit Bids in CIL and its Subsidiaries."

In the instant case, you are defaulter for the tendered item, hence imposition of penalty will be as per the provisions covered under the above-mentioned amended clause of NIT.

In view of the above, your firm is hereby banned for 02 (Two) years from being eligible to submit bids in CIL and its Subsidiaries as per the provisions of NIT.


