ORDER FOR BANNING OF BUSINESS


An NIT bearing No. "GM(R)/SO(EnM)/Rjp/21-22/Et/56 Dated:30.12.2021, Tender ID-2021_CCL_227381_1 for the work "Supply, Installation, testing and commissioning of 09 nos of CCTV cameras along with all allied accessories at different locations of Rajrappa Township with central monitoring at Rajrappa Police station with 01 year warranty" was floated on CIL e-procurement portal.

After opening of price bid on scheduled date & time, You i.e Rama Tech was found L-1 bidder. Moreover, Technical Evaluation of documents uploaded by you was done as per NIT and some deficiency was found by the T.C in uploaded documents. Accordingly, you were requested online to upload required shortfall documents within the scheduled time from 24/01/2022 to 31/01/2022 on e-procurement portal of CIL, but you failed to submit requisite documents as per eligibility criteria.

As per clause 15.E of tender evaluation of NIT, which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by the L-1 bidder online is found to be wrong by tender evaluation of scanned documents uploaded by bidder which changes the eligibility status of the bidder, then his bid shall be rejected and the bidder will be banned for two(02) years from being eligible to submit bids in CIL and its subsidiary from date of issue of this letter. This banning shall be done under the provision of NIT and online blocking of all the bidders shall be done in CIL e-procurement portal."

Under the facts and circumstances mentioned above, as per clause 15.2.E under tender evaluation of NIT, business in the name Rama Tech, Flat No 15C, Tower 4, Pocket A, Sector 105, Noida, Uttar Pradesh, Pin Code-201301 PAN- ASAPT8174A, Login id- ramatechg@gmail.com is hereby banned for (02) two years from being eligible to submit bids in CIL and its subsidiaries with immediate effect.
