### **ORDER FOR BANNING OF BUSINESS**

An NIT bearing No. SO(E&M)/PPR/e-NIT/21-22/103, dated: 19.11.2021, Tender ID: 2021\_CCL\_223363\_1 for the work titled "Providing and fixing of 08 nos. lightning arrestor System of Sharaswati Shishu Vidya mandir at Purni Ray under GM Unit, Piparwar Area" was floated on the e-Procurement Portal of CIL.


After opening of price bid on scheduled date and time, M/s LINGA ENGICON PRIVATE LIMITED, Address: - Plot No. 141/A, Mahto Tola, Govind market, Balidih, Dist: Bokaro, Jharkhand - 827014, E-mail: [sachin.mahto09@gmail.com](mailto:sachin.mahto09@gmail.com), Mob: 9835365734 was found L-1 bidder. Moreover, technical Evaluation of documents uploaded by L-1 bidder i.e. M/s LINGA ENGICON PRIVATE LIMITED was done as per NIT and some deficiency was found by the Tender Committee in the uploaded documents. It was observed that (1) Certificate of incorporation of the company (2) Undertaking as per Annexure X and (3) Valid electrical Contractor's license and license of Supervisor and wireman has not been submitted, which are required as per clause No. 7.b.3.iii, 7.c.2 and 7.c.3 of the NIT.

Certificate of incorporation of the company required as per clause No. 7.b.3.iii of NIT (which has not been submitted) is part of the document required for establishing the Legal status of bidder and as per clause No. 7.b of NIT, the document regarding Legal status of the bidder has to be considered from the Bidder's space / My document i.e. no further clarification can be sought from bidder in this regard.

**As Per clause 11.E of the e-NIT** which states that "In case the **L-1 bidder fails to submit requisite documents** online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, **which changes the eligibility status of the bidder, then his bid shall be rejected the bidder will be banned for (02) two years** from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal."
