ORDER FOR BANNING OF BUSINESS

An NIT bearing No.- SO(E&M)/AA/e-NIT/21-22/46, Dated: 18.01.2022, Tender Id: 2022_CCL_230012_1 for the work titled "Hiring of 03 Nos. of AC hard top covered jeeps of 7-seater, engine 1493 cc or above and diesel version (like Bolero or equivalent) on daily hire basis (12 hours service along with Driver in each vehicle) for P.O., PE(X) and PE(EnM) of Gidi-A Colliery Argada Area for 03 Yrs." was floated on e-Procurement Portal.

After opening of price bid on scheduled date and time, **KUNDAN KUMAR SINGH** was found techno commercially established L-1 bidder during the tender proceeding. But in the meantime, from central dispatch of Argada Area vide dak No. 9416 dtd: 16.03.2022 a letter from **KUNDAN KUMAR SINGH** was received at the Office of Tender Inviting Authority with a request for withdrawal of his Bid against the instant tender ID i.e., **2022_CCL_230012_1**. This matter was put before the TC members and as per Clause 28.II.B.a of Standard Operating Procedure for Withdrawal of Bid in NIT, the TC members decided to cross check for whether the request for withdrawal of offer has been received from right source & authentic.

Accordingly, as per Clause 28.II.B.a a letter was issued by tender inviting authority vide ref no. SO (E&M)/AA/e-NIT46/Confirmation of withdrawal of Bid/ 399 dtd 23.03.2022 to the Techno Commercially established L1 i.e., **KUNDAN KUMAR SINGH** and sent via speed Post and e-mail. The Techno commercially established L1 Bidder i.e., **KUNDAN KUMAR SINGH** responded to the E-Mail within a time frame of 10 days and confirmed that he is withdrawing his Bid against tender ID: **2022_CCL_230012_1**.

The Response of the L1 Bidder was put before the TC members and the TC observed that the request of withdrawal of bid has been received from right source & authentic, and is acceptable with the condition in NIT Clause 27.1 & 27.1.ii (Modification and Withdrawal of Bid) i.e., "The bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter." This banning shall be done under the provisions of the NIT ad online blocking of the bidder shall be done in CIL e-Procurement Portal".

The matter has been informed to the L1 Bidder i.e., **KUNDAN KUMAR SINGH** vide letter No. SO(E&M)/AA/22-23/28 Dated: 25.04.2022 which was sent to him via speed post.

Under the facts and circumstances mentioned above, as per clause 27.1 & 27.1.ii (Modification and Withdrawal of Bid) under Tender Evaluation of the NIT the business in the name and style **KUNDAN KUMAR SINGH** Login Id: kundansingh3047@gmail.com, PAN No **DUQPS5451A** & **GSTIN: - GST unregistered**, is hereby banned for 02(Two) Years from being eligible to submit bid in CIL and its subsidiaries with immediate effect.

This issues with the approval of the Competent Authority.
