
Sub: - Waival of banning imposed on National Carrier & Construction for 02(Two) year from being eligible to submit Bids in CIL and its subsidiaries.

Dear Sir,

You have participated in tender for the work "Construction of siltation pond near Konar river side at Jarangdih OCP mine under Jarangdih Colliery, Kathara area" having Tender Id- 2021_CCL_205247_1. You were banned for 02(Two) year from being eligible to submit Bids in CIL and its subsidiaries vide letter no. CCL/GM(KTA)/SO(C)/2021-22/Banning/929 dated 12.11.2021 due to non-submission of clarification documents for subject tender as per provisions of NIT.
