**ORDER FOR BANNING OF BUSINESS**



An NIT bearing no. SO(EnM)/PPR/eNIT/20-21/96 ; Dated: 31.12.2020, Tender ID: 2020\_CCL\_191978\_1 for the work titled "Daily assistance in maintenance of 33 kV Central Switching Station, Various HT / LT Overhead lines under GM Unit, Piparwar Area for a period of 01(One) year" was floated on CIL e-Procurement Portal.

After opening of price bid on scheduled date & time, M/s Singh Traders, Purana Chief House, Giddi A, Hazaribagh, Jharkhand - 829109 was found L-1 bidder. Moreover, Technical Evaluation of documents uploaded by L-1 bidder i.e. M/s Singh Traders was done as per NIT and some deficiency was found by TC in the uploaded documents. Accordingly, M/s Singh Traders was requested online to upload required shortfall documents within in scheduled time from 20.01.2021 AT 11.00 AM to 27.01.2021 AT 11.00 AM (07 days) on e-portal of Coal India Limited as per clause no. 14.2.B of the e-NIT. M/s Singh Traders has not uploaded the required shortfall documents with in scheduled time period.

**As per clause 14.2.E of the e-NIT, which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected the bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal."**

Under the facts and circumstances mentioned above, as per clause 14.2.B, C & E under Tender Evaluation of the NIT the business in the name and style M/s Singh Traders, Proprieter: - Prashant Singh, Address:- Purana Chief House, Giddi A, Hazaribagh, Jharkhand - 829109, login id:- singhprashant49733@gmail.com, PAN:- EGBPS6874M & GSTIN:- 20EGBPS6874M1ZV is hereby banned for 02 (Two) years from being eligible to submit bid in CIL and its subsidiaries with immediate effect.
