In reference to the above captioned matter this is to inform you the following:

You have submitted partnership deed dated: 17.11.2021 of the partnership firm Ganesh Karmakar.

As per partnership deed Sri Ganesh Karmakar S/o Late Krishna Karmakar and Sri Chitranjan Karmakar S/O Sri Ganesh Karmakar have carrying on business in the name and style of "Ganesh Karmakar" with its office near Shivam City, Rajkishore Nagar, Bilaspur, (CG) vide partnership deed executed dtd. 2nd May 2019.

Further it is mentioned that, whereas due to old age and suffering from seekness, party no. 1 Ganesh Karmakar expressed his willingness to retire from partnership business with effect from 17 Nov. 2021 after closing and whereas Smt Jyostna Karmakar D/O Khetramohan Maharana have desire to join the partnership business from 17th day of November 2021.

For smooth running the business, the remaining partner Shri Chitranjan Karmakar has agreed to admit Smt. Jyostna Karmakar in partnership business and to continue the business with effect from 17th November 2021 in the same name and style.

It is also agreed among the parties that the assets and liabilities of old partnership firm shall be taken over by the new partnership firm.

Now This deed of partnership is executed on the 17th November 2021 between:-

However the partnership deed dtd.: 17.11.2021 doesn't have any mentioned about the death of Sri Ganesh Karmakar. The partnership deed states: -

From above it has been observed that you have hidden the fact and tried to mislead the company by submitting false and fabricated document for partnership deed.

The undertaking (Annexure XVIII) point no. 7 submitted by the bidder, M/S Ganesh Karmakar during bid submission states:-

Quote-

"If any information and document submitted is found to be false/ incorrect at any time, department may cancel my/our Bid and action as deemed fit may be taken against me/us, including termination of the contract, forfeiture of all dues including Earnest Money and banning of our firm and all partners of the firm etc".

As per letter of bid, Annexure-I of the NIT which has been accepted unconditionally by the bidder, M/S Ganesh Karmakar:-

If any information furnished by me/us towards eligibility criteria of this bid is found to be incorrect at any time, penal action as deemed fit may be taken against me/us for which I/We shall have no claim against CIL/Subsidiary"

A Show Cause was issued vide no. Town Admn./DHC/NIT-22/23-24/179, dated 12.04.2023 intimating the above misconduct, and advising therein to submit the reply within 15 days from the issuance of the Show Cause Notice as to why actions as per the terms of tender document may not be taken against you.

You had not submitted any reply of the show cause letter.
