Subject: **Banning of MAA BHAGWATI CONSTRUCTIONS for a period of One (01) years & cancellation of award with forfeiture of EMD.**

3. Letter vide no. GM (C)/Wel. & Serv. /DHC/10565/23-24/4783-85 dated 04.11.2023.

Dear Sir,

You have been awarded the work for "**Repair and maintenance of Janta Majdoor sangh office and OBC cell adjacent to CRD building at DHC under TA department, CCL, Ranchi**" vide above referred award of work, you had to submit the Performance Security Deposit (PSD) amounting to Rs.8,065/- (Rupees Eight thousand and sixty five) only & Additional Performance Security Deposit (APSD) amounting to Rs.45,011.00 (Rupees Forty-five thousand eleven) only within 21 days of receipt of award of work. But you have failed to submit the requisite PSD and APSD amount within stipulated time.

After expiry of scheduled period of 21 days for submission of PSD & APSD, a Show cause letter vide no GM (C)/Wel. & Serv. /DHC/10565/23-24/4783-85 dated 04.11.2023 was sent to you to explain within 7 days from the date of issue of letter, why action shall not be initiated against you as per provisions of award of work and tender document /NIT. But, you have not responded to the above letter. Also, you have not commenced the work as confirmed by EIC. As such, you have violated the following provisions of NIT & Tender document:

1. Clause no. 26 of NIT :-

**Quote**

**Letter of Acceptance (LOA)/Work Order/Agreement:**

The Bidder, whose Bid has been accepted, will be notified /communicated by the Employer electronically online on the e-procurement portal of CIL/ Subsidiary prior to expiration of the Bid validity period. The L-1 bidder will get the information regarding award of work on their personalised dash-board on-line. On

receipt of Letter of Acceptance (LOA)/Work Order of the tender issued by the Company, the successful tenderer shall execute contract agreement in the company's prescribed form for the due fulfilment of the contract. Failure to enter into the required contract within the specified period in the work order shall entail cancellation of LOA/work order and forfeiture of the Earnest Money. In addition, the department may debar the bidder from participating in future bids for at least 12 months as per Guidelines on Debarment of firms from Bidding.

2. Clause no. 4.2 of conditions of contract of Tender document / NIT regarding non-submission of PSD:

Quote

*In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work may be cancelled with forfeiture of the bid security/earnest money.*

*Additionally, the company shall debar such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum one year from the date of issue of such letter.*

3. Clause no. 4.8 of conditions of contract of Tender document / NIT regarding non-submission of APSD:

Quote

*Additional performance security (APS) shall be furnished within 21 days of issuance of LOA by the successful bidder.*

*Failure to submit such additional performance security shall result into cancellation of the contract with forfeiture of earnest money.*

*Additionally, the company shall ban such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum one year from the date of issue of such letter.*

4. Provision of letter of bid inter-alia accepted unconditionally by bidder during bid submission:

Quote

*Should this bid be accepted, we agree to furnish Performance Security within stipulated date and commence the work within stipulated date. In case of our failure to abide by the said provision Central Coalfields Ltd. shall, without prejudice to any other right or remedy, be at liberty to "cancel the letter of acceptance/ award and to forfeit the Earnest Money and also debar us from participating in future tenders for a minimum period 12 months" OR to act as specified in the NIT.*

5. Sl. No. 3 and 23(a & b) of award of work:

Quote

*3. The earnest money amounting to Rs.4,400/- online through Axis Aggregator Bank Netbanking vide Bank / UTR No.144366368 and Ref. no.295888974803 has been retained by the company (CCL) as part of Performance Security Money.*

*You are further required to deposit Rs.8,065/- (Rupees Eight thousand and sixty five) only with the company in the form of a Bank Guarantee (if applicable) or Govt. Securities or FDR duly pledged in favour of Central Coalfields Limited, Ranchi or through NEFT/RTGS in the designated account of CCL, within 21 (Twenty one) days of receipt of this letter thus making the total performance security money amount to Rs. 12,465/- (Rupees Twelve thousand four hundred sixty five) only i.e. 5% of the contract amount. If you fail to deposit*

the above amount within the prescribed time, the Award of Work may be cancelled and Earnest Money will be forfeited. In addition to the above penal measures, department shall debar you from participating in future bids for at least twelve (12) months.

Further you have to deposit Rs.45,011.00 (Rupees Forty-five thousand eleven) only as Additional performance security as per clause no. 4.8 of GTC of Conditions of Contract of tender documents alongwith Performance Security in form of a Bank Guarantee (if applicable) or Govt. Securities or FDR duly pledged in favour of Central Coalfields Limited, Ranchi or through NEFT/RTGS in the designated account of CCL, Ranchi within 21 (Twenty one) days of receipt of this letter. If you fail to deposit the above amount within the prescribed time, the Award of Work may be cancelled and Earnest Money will be forfeited. In addition to the above penal measures, department shall debar you from participating in future bids for atleast twelve (12) months.

23. You are requested to submit the following for execution of agreement / Detail Work Order within 21 (twenty-one) days from the receipt of this Award of Work: –

- a. An amount of Rs.8,065/- (Rupees Eight thousand and sixty five) only towards Performance Security.
- b. An amount of Rs.45,011.00 (Rupees Forty-five thousand eleven) only towards Additional Performance Security


In view of above clauses of work order, conditions of contract of NIT and Letter of Bid, following penal action has been imposed upon you:

2. Banning of MAA BHAGWATI CONSTRUCTIONS, Proprietorship firm (PAN-KBSPS6145H) (Proprietor name - Rishab Singh) from participating in future tenders in CCL for a period of One (01) year, from the date of issue of this letter.
