Dear Sir.

An open Tender was floated from BCCL for hiring of 01 no. of LCV for the use at Jharia Master Plan Dept. BCCL HQ for a period of 05 years through GeM Portal vide BID No – GEM/2023/B/3847634 dated: 19-08-2023. In the said tender, after opening of price bid, you were L-1 bidder. Accordingly, Upon recommendation of the tender committee, GeM contract was issued to you for hiring of 01 no. of LCV (Bolero/Sumo/Eqv.) vehicle vide GEM Contract no- 511687773997174, dated:13-11-2023. You had claimed exemption from submission of EMD (being a MSE). As neither PBG was submitted nor the work was started on schedule time, incident no. 1759421 was raised against you on GeM portal. In response to the incident, you replied that vehicle shall not be provided by you.

The matter was put up before the competent authority. Since you are the L-1 bidder in the said tender, management of BCCL has decided that following action is to be taken against you as per clause 2 & 4 of Banning of Business under Additional Terms & Conditions of GeM bid, in view of the seriousness and gravity of the act on your part as a bidder (Satyabhama Devi):

"To debar/ban (You) Satyabhama Devi from participating in any future tender in BCCL for a period of One year from the date of issue of this letter."

Accordingly, (You) Satyabhama Devi is hereby debarred from participating in future bids in all tenders of BCCL in individual capacity or as a Joint Venture, for a period of 01 (One) year from the date of issue of this order.
