Dear Sir.

The subject work awarded to you was cancelled and Earnest money deposit (EMD) amounting to Rs.6,950.00, was also forfeited, as you have not submitted the Performance Security Deposit within the stipulated time period.

Further, for banning of business as per clause no. 4 of GTC, "In case the successful bidder fails to submit the Performance Security, if any, within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security/earnest money. Additionally, the company shall ban such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum one year from the date of issue of such letter". And also as per guidelines for banning of business, observing principles of natural justice before banning agency, you were also given 15 days to represent yourself to the competent authority" however, you have not responded.

The agency namely "Omkar Mahto" is hereby debarred from participating in further tenders in Central Coalfields Limited (CCL) for a period of (01) one year from the date of issue of this letter.
