
In reference of above mentioned subject you have submitted online tender which was opened on 12.01.2021 & you were the L-1 bidder comparative statement of part – I (i.e. technical bid) was prepared. The work was awarded to Turo Infra pvt. Ltd. Vide letter no. SO(C)/PPR/Award letter/20-21/1036-41 Dated.15.03.2021 & same has been uploded on 15.03.2021. As per award Sl.No. 03 bidder (Turo Infra pvt. Ltd) have to deposit Rs. 2,210.00 only as bid security upto 05.04.2021 but same has been not deposited by the firm. Accordingly two letter vide no. SO(C)/PPR/2021-2022/36 Dated. 08.04.2021 and SO(C)/PPR/2021-2022/60 Dated. 15.04.2021 (**REMINDER - 1**) was sent to you on your registered email ID but no response come from your end.

Hence in view of above as per **NIT clause no.10.3. INSTRUCTION TO BIDDERS & Annexure XVII:**

- 10.3** The defaulting contractor will be banned for 02 (two) years from being eligible to submit Bids in CIL and its subsidiaries from the date of issue of such letter if:
- (a) if the Bidder withdraws the Bid after Bid opening during the period of Bid validity/extended validity with mutual consent;
- OR**
- (b) in the case of a successful Bidder, if the Bidder fails within the specified time limit to:
(i) sign the Agreement; **OR** (ii) Furnish the required Performance Security/ Security Deposit.
- This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal.

In view of above, competent authority approved for debar of your firm i.e. Turo Infra Pvt. Ltd Pan No. AAHCT9378E for the period of two (02) years.
