Dear Sir,

You have been awarded the work for "Construction of Approach Road for High Level Bridge under Govindpur PH-II OCP, Kathara Area", e-Tender Notice no. 11 of 2020-21, vide ref. no. GM(C)/2290/Kathara/2021-22/180, dated 12-07-2021. As per SI. No. 3 & 28 of award of work, you had to submit the Performance Security Deposit (PSD) amounting to ₹ 16,78,322/- within 21 days of issuance of award of work. But you have failed to submit the requisite PSD amount within stipulated time. It is also confirmed by the Area authority that you have not taken any action to commence the work.

After expiry of scheduled period of 21 days for submission of PSD, a letter vide no GM(C)/2020-21/239, dated 03-08-2021 was sent to you to explain within 7 days from the date of issue of letter, why action shall not be initiated against you as per provisions of award of work and tender document /NIT. But, you have not responded to the above letter. Also, you have not commenced the work as confirmed by Area authority. As such, you have violated the following provisions of NIT & Tender document:

1. Clause no. 4.2 of conditions of contract of Tender document / NIT regarding non-submission of PSD:

Quote

In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled.

Additionally, the company shall ban such defaulting contractor for a period of 02 (two years) from being eligible to submit Bids in CIL and its subsidiaries from the date of issue of such letter.

This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal.

In case of JV/Partnership firm, the banning shall also be applicable to all individual partners of JV/Partnership firm.

2. Sl. No. 3 and 28(a) of award of work:

Quote

- 3) You are required to deposit ₹16,78,322/- (Rupees Sixteen lakh seventy eight thousand three hundred twenty two) only towards Performance Security Deposit (1st part of Security Deposit) i.e. 5% of the contract amount with the company in the form of a Bank Guarantee (if applicable) or Govt. Securities or FDR duly pledged in favour of CCL or demand draft in favour of Central Coalfields Limited, Ranchi from any Scheduled Bank payable at Ranchi within 21 (Twenty one) days of issuance of this letter. Performance security i.e. 5% of Contract amount shall be refunded as per provisions of conditions of contract. If you fail to deposit the above amount within the prescribed time, the Award of Work shall be cancelled. In addition to the above penal measures, the company shall ban you for a period of 02 (two years) from being eligible to submit Bids in CIL and its subsidiaries from the date of issue of such letter.
- 28) You are requested to submit the following for execution of agreement / Detail Work Order within 21 (twenty one) days from the issue of this Award of Work: –

(a) An amount of ₹ 16,78,322/- (Rupees Sixteen lakh seventy eight thousand three hundred twenty two) only towards Performance Security in the form given below:-Bank Guarantee in the form given in the bid document from any Scheduled Bank. The BG issued by outstation Bank shall be operative at its local Branch at Ranchi. Govt. Securities or FDR duly pledged in favour of Central Coalfields Limited. Demand Draft drawn in favour of Central Coalfields Limited on any Scheduled Bank payable at its Branch at Ranchi.

3. Provision of letter of bid inter-alia accepted by bidder during bid submission:

Quote

Should this bid be accepted, I/we agree to furnish Performance Security within stipulated date and commence the work within stipulated date. In case of my/our failure to abide by the said provision, Central Coalfields Limited shall, without prejudice to any other right or remedy, be at liberty to cancel the letter of acceptance/ work order /award and also ban me/us for 02 (two years) from being eligible to submit Bids in CIL and its subsidiaries.

In view of above clauses of work order, conditions of contract of NIT and Letter of Bid, following penalty is hereby imposed on you from the date of issue of this letter:

- 1) Cancellation of award of the subject work.
- 2) Banning of M/s Ajay Singh (PAN- CGAPS3989Q) for 02 (two years) from being eligible to submit Bids in CIL and its subsidiaries, from the date of issue of this letter.
