- (2) The work was awarded to L1 Bidder M/s BGR LOGISTICS JV.
- (3) LOA was issued vide letter no. GM(KTA)/SO(M)/Tender/2021/NIT571/551 Dated: 28.05.2021.
- (4) Site hand over was given by letter no. PO-JRD/2021/580 dated 05.06.2021.
- (5) M/s BGR Logistics JV has started the work accordingly, from 04.07.2021.
- (6) M/s BGR Logistics JV had stopped the work from dated 27.07.2021 completely.
- (7) Number of letters were given to the contractor to start the work but he has not started the work.
- (8) Performance Security Money in the form of FD for Rs.4,80,700/- was submitted on date 17.06.2021 and was confirmed from concerned bank on dated 05.08.2021.
- (9) Number of mails and letters were given to M/s BGR Logistics JV to come for agreement within 14 days from confirmation of Performance Security vide letter no. (i) GM(KTA)/SO(M)/NIT571/2021/T/645/686 dated 15/16.07.2021. (ii) Letter no. GM(KTA)/SO(M)/NIT571/2021/T/645/748 dated 07.08.2021 (iii) Letter no. "The Agreement will incorporate all agreements between the Employer and the successful Bidder and shall be executed within 14 days of confirmation of Performance Security and Additional Performance Security (if any) submitted by the contractor as per contract conditions. In case of failure to enter in to agreement within specified period the contract will be terminated and the bidder will be banned for two years from being eligible to submit Bids in CIL and its subsidiaries.

No payment for the work shall be made before execution of this agreement". Unquote.

As M/s BGR Logistics JV <u>failed to enter into agreement within 14 days</u> of confirmation of performance security; so a proposal for termination of the contract awarded to M/s BGR Logistics JV and for banning for two years of M/s BGR Logistics JV and partners was

initiated as per clause no. 23:3 of ITB and has been approved by the competent authority vide e-office no.557503.

Hence, the subject contract awarded to M/s BGR Logistics JV vide work order no. GM(KTA)/SO(M)/Tender/JRD Stock-JRD FB/NIT571/2021/T/645/642 dated 30.06.2021 is being terminated,
