ORDER FOR BANNING OF BUSINESS

An NIT bearing No. GM(R)/SO(EnM)/Rjp/20-21/Et/50 dated 20.03.2021, Tender ID- 2021_CCL_201318_1 for the work titled "Connection, Testing & commissioning of 2Nos. of 33KV, 1250A, Outdoor type SF6 Breakers make ABB of 12.5MVA, 33KV/6.6KV Transformers installed at 2X12.5MVA, 33KV/6.6KV Main substation of Rajrappa Project "was floated on CIL e-procurement portal.

After opening of price bid on scheduled date & time, Rohit Electricals, Devi Mandop, near Tenderbagicha, Tilta, Kathitard, Ratu, Ranchi, Jharkhand, 83400 was found L-1 bidder. Moreover, Technical Evaluation of documents uploaded by L-1 bidder Rohit Electricals was done as per NIT and some deficiency was found by the T.C in uploaded documents. Accordingly, Rohit Electricals was requested online to upload required shortfall documents within the scheduled time from 02/06/2021 to 09/06/2021 on e-procurement portal of CIL. Rohit Electricals has uploaded the required shortfall documents within scheduled time period but during technical evaluation, it was found by T.C that the information given by the L-1 bidder in uploaded shortfall documents is found to be contradictory and wrong.

As per clause 14.2.E of tender evaluation of NIT, which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by the L-1 bidder online is found to be wrong by tender evaluation of scanned documents uploaded by bidder which changes the eligibility status of the bidder, then his bid shall be rejected and the bidder will be banned for two(02) years from being eligible to submit bids in CIL and its subsidiary from date of issue of this letter. This banning shall be done under the provision of NIT and online blocking of all the bidders shall be done in CIL e-procurement portal."

Under the facts and circumstances mentioned above, as per clause 14.2.B,C &E under tender evaluation of NIT, business in the name Rohit Electricals, Devi Mandop, near Tenderbagicha, Tilta, Kathitard, Ratu, Ranchi, Jharkhand, 83400, Login id- manoikrsingh4932@gmail.com, PAN-AAPFR7673D, GST No 20AAPFR7673D1Z3, is hereby banned for (02) two years from being eligible to submit bids in CIL and its subsidiaries with immediate effect.
