As per the subject sanction-cum-letter of award, INTERNATIONAL INFRASTRUCTURES was required to deposit 3% of the contract amount as Performance Security Deposit within 21 days of issuance of the sanction-cum-letter of award. You didn't submit the Performance Security Deposit till date.


Therefore, as per the clause 3 of the subject sanction-cum-letter of award and clause 4.2 of General Terms and Conditions of the subject NIT, ***the letter of award is being cancelled along with banning the defaulting contractor/party, i.e. INTERNATIONAL INFRASTRUCTURES for a period of 02 (two years) from being eligible to submit Bids in the CIL and its subsidiaries.***

***The banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in the CIL eTendering Portal.***

Once a contracting entity is banned, it shall be extended to the constituents of that entity, all the partners in case of Partnership Firm, owner/proprietor in case of Proprietorship Firm and all the Directors in case of Limited Company. If such banned owner/Proprietor/ Partner/Director make/form different Firms/entity and attempts to participate in tenders, the same will not be entertained during the currency of such banning.
