Dear Sir,

With reference to above subject matter, the e-tender was floated for the work of "Cleaning of 03 nos. electronic road weigh bridges including W.B Room No.01,02 & 03 at Tetariakhar OCP under Rajhara Area" vide Ref. No. SO(C)/Ra/e-Tender/02/21-22/ 29 Dated: -25.06.2021. and opened on 10.07.2021. In the Tender Evaluation Process, you were selected as L1 bidder i.e. M/s Prince Kumar. The tender committee therefore recommended award of the subject work in favor of L1 bidder i.e. M/s Prince Kumar, Tori, Chandwa, Dist: Latehar. The Award of work was issued on 27.07.2021 and the bidder was instructed to start the work from 02.08.2021 or handing over of site whichever is earlier. As per the AOW, point No. 3, You are further required to deposit performance security deposit of Rs. 13, 400 and Security Additional Security deposit (As per 14.2 of NIT) within 21 days of issuance of this letter.

In this respect the work was awarded to the contractor with Ref No. CCL/RA/Civil/AOW/2021-22/07 dated 27/07/2021, Further, the Site Handover Certificate was emailed to you with Reference Number GM(RA)/Civil/Justification/2021/57 dated 05.08.2021 and you were instructed to commence the work and deposit the performance Security Deposit/ Additional security deposit within stipulated time. Also, the final notice was issued to you with Reference number GM(RA)/Civil/Contract/Justification/2021-22/68 dated 18/08/2021 and instructed to start the work and deposit the Performance Security Deposit/ Additional Security Deposit till 23.08.2021. Also, a letter was received by the PE(Civil), Rajhara Area regarding "non-commencement of the awarded work and non-submission of Performance Security deposit/Additional Security deposit within stipulated time period by the contractor" and requested for necessary action against the contractor as per AOW/NIT and initiation of re-tendering process of this work.

In view of the above fact, the bidder has neither started the work nor any communication was made from the contractor side regarding payment of Performance Security Deposit/ Additional Security Deposit. Thus, as per the AOW, point No. 3, "You are further required to deposit performance security deposit of Rs. 13, 400 and Security Additional Security deposit (As per 14.2 of NIT) within 21 days of issuance of this letter. If you fail to deposit the above amount within the prescribed time, the award of work may be cancelled and Security money will be forfeited." The date of submission is







already completed on 23.08.2021 and still no communication was made regarding start of the work and deposition of Security amount from contractor side.

As per NIT clause no.24, Letter of Acceptance (LOA)/Work Order/Agreement:

The Bidder, whose Bid has been accepted, will be notified /communicated by the Employer electronically online on the e-procurement portal of CIL/ Subsidiary prior to expiration of the Bid validity period. The L-1 bidder will get the information regarding award of work on their personalised dash-board on-line. On receipt of Letter of Acceptance (LOA)/Work Order of the tender issued by the Company, the successful tenderer shall execute contract agreement in the company's prescribed form for the due fulfillment of the contract. Failure to enter into the required contract within the specified period in the work order shall entail cancellation of LOA/work order. In addition, the bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of

Hence in view of NIT clause no. 11 " Letter of Acceptance (LOA)/Work Order/Agreement", The tender has been cancelled and the and your firm M/s Prince Kumar, Pan No. KKJPK8157B has been banned / debarred for the period of two (02) years, as L1 bidder due to non-commencement of the awarded work and non-submission of PSD/APSD within stipulated time period.
