ORDER FOR BANNING OF BUSINESS

An NIT bearing No. PE(EnM)/Kargali OCP/e-tender/21-22/04 dated 22/07/2021, Tender ID-2021_CCL_212483_1, for the Work titled "Bush cutting, trimming of branches of tree and surface dressing under overhead line at different places in respect of Kargali OCP, B&K Area.

After Opening of Price Bid on scheduled date & time, M/S Nishant Kumar, Flat No. 15, Siddhartha B, Sri Ram Vatika, Chira Chas, Bokaro Jharkhand, 827013 was found L-1 bidder. On dated: 10 Aug 2021 M/S Nishant Kumar has withdrawn his bid vide e.mail sent through email .id. nishzb9122gmail,com to email id of PE(E&M), Kargali and for same confirmation has been given by Bidder on e-portal site. Hence per NIT clause No. 11 Which states as follows

As per NIT clause No. 11 Which states as follows "Bidders may withdraw their bids online within the end date of bid submission However, if the bidder once withdraws his bid, he will not be able to resubmit the bid in that particular tender. For withdrawal of bid after the end date of bid submission, the bidder will have to make a request in writing to the Tender Inviting Authority. Withdrawal of bid may be allowed till issue of work order/LOA with the following provision of penal action:

The bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter.changes the eligibility status of the bidder, than his bid shall be rejected the bidder will be banned for (02)two years from being eligible to submit bids in CIL and its subsidiary from date of issue of this letter. This banding shall be done under the provision of NIT and online blocking all the bidders shall be done in CIL e-Procurement portal until the Portal."
