ORDER FOR BANNING OF BUSINESS

An NIT bearing No. "GM(R)/SO(EnM)/Rjp/21-22/Et/09 Dated:17.05.2021, Tender ID-2021_CCL_206209_1 for the work titled Hiring of 04(Four) Nos. diesel Jeep like Scorpio/Bolero/Sumo or equivalent for 03 Years, 24 Hrs engagement for Rajrappa Washery Project of Rajrappa Area" was floated on CIL e-procurement portal.

After opening of price bid on scheduled date & time, M/S Jagdeo Mahto was found L-1 bidder. Moreover, Technical Evaluation of documents uploaded by bidder was done as per NIT and some deficiency was found by the T.C in uploaded documents. Accordingly, L-1 bidder was requested online to upload required shortfall documents within the scheduled time from 09/06/2021 to 16/06/2021 on e-procurement portal of CIL, but the bidder had not responded for the required shortfall documents within scheduled time period.

As per clause 14.2.E of tender evaluation of NIT, which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by the L-1 bidder online is found to be wrong by tender evaluation of scanned documents uploaded by bidder which changes the eligibility status of the bidder, then his bid shall be rejected and the bidder will be banned for two(02) years from being eligible to submit bids in CIL and its subsidiary from date of issue of this letter. This banning shall be done under the provision of NIT and online blocking of all the bidders shall be done in CIL e-procurement portal."

Under the facts and circumstances mentioned above, as per clause 14.2.B,C &E under tender evaluation of NIT, business in the name M/S Jagdeo Mahto,S/O Rati Mahto, Arabasti Tola Baghlata Near Hanuman Mandir, P.S-Mandu Ara, Sarubera, Distt-Ramgarh, Jharkhand, 829134, PAN-CRRPM8893B, Login id-ara.jagdevmahto@gmail.com is hereby banned for (02) two years from being eligible to submit bids in CIL and its subsidiaries with immediate effect.
