Sub.: Debarring of Shri Jagroop Singh for two years from participating in tenders in Central Coalfields Limited (CCL)/ CIL Subsidiaries due to shows his inability to execute the work.

Dear Sir,

In reference to the above captioned matter this is to inform you the following-

That in response to the above referred e-tender Shri Jagroop Singh i.e. L1 bidder given a letter in which he stated that he is unable to do the work due poor physical & economical conditions.

As per Cl. No 11 (Modification and Withdrawal of Bid) are as follows-

Modification of the submitted bid shall be allowed online only before the deadline of submission of tender and the bidder may modify and resubmit the bid online as many times as he may wish.

Bidders may withdraw their bids online within the end date of bid submission and their EMD will be refunded. However, if the bidder once withdraws his bid, he will not be able to resubmit the bid in that particular tender. For withdrawal of bid after the end date of bid submission, the bidder will have to make a request in writing to the Tender Inviting Authority. Withdrawal of bid may be allowed till issue of work order/LOA with the following provision of penal action:

~~the EMD will be forfeited and~~ the bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal.

~~The bidder will be debarred for 1(One) year from participating in tenders in CCL.~~
The Price-bid of all eligible bidders including this bidder will be opened and action will follow as under:

- i). If the bidder withdrawing his bid is other than L 1, the tender process shall go on.
- ii). If the bidder withdrawing his bid is L-1, then re-tender will be done.

Note:

In case of above, a letter will be issued to the bidder by Tender Inviting Authority with the approval of Tender Accepting Authority (in case Board is Tender Accepting Authority then with the approval of CMD), stating that the ~~EMD of bidder is forfeited, and this bidder is debarred for one year from participating in tenders in CCL~~ the bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal. This letter will be circulated to all Areas and CIL/Subsidiary HQ and the updated list will be maintained by all Tender Inviting Authority/Evaluators.

Penal action against clauses above will be enforced from the date of issue of such order.

iii) Standard Operative Procedure (SOP) for managing the cases of Withdrawal of Bids after end date of submission of bid shall be as per e-Procurement System of CIL/Subsidiary and as mentioned at Clause No. 14 of Chapter 1.

Additionally, the company shall ban such defaulting contractor for a period of 02 (two years) from being eligible to submit Bids in CIL and its subsidiaries from the date of issue of such letter.

This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal.

In case of JV/Partnership firm, the banning shall also be applicable to all individual partners of JV/Partnership firm

In view of the above Clause of NIT, following penalty is hereby imposed on you from the date of issue of this letter.

Debarring of Shri Jagroop Singh, PAN No.: HFUPS4787G for 2 years from participating in tenders in Central Coalfields Limited (CCL) / CIL Subsidiaries .
