ORDER FOR BANNING OF BUSINESS



One NIT bearing no. GM (NK)/EnM/eNIT/2020-21/104 dated 20.03.2021, Tender ID: 2021_CCL_202632_1 for the work of “**Complete repairing and rewinding of 1 MVA, 11 KV / 3.3 KV Transformer, Sl. No. 99533, Make: Govt. Electric Factory installed at Dakra Substation for supplying power to Mohan Nagar Colony Feeder under Dakra Project, NK Area**” was floated.

After rejection of L-1 bidder in terms of Clause No. 14.2.G under Evaluation of Tender of NIT, Technical evaluation of documents of L-2 bidder who become L-1 bidder (declared) i.e. **M/s Pooja Electricals, Ward No. 17, Main Road, Chanwaridand ATA Chouk, Manendragarh – 497442, Chhattisgarh** was evaluated and some deficiency in the uploaded documents was found. Hence, M/s Pooja Electricals was requested online under Confirmatory documents to upload the required confirmatory documents allowing 07 days (07x24 hrs) as per Clause No. 14.2.B under Evaluation of Tender of NIT.

M/s Pooja Electricals responded and uploaded the required confirmatory documents as asked online within the scheduled time and period. On further scrutiny including already available documents as well as documents uploaded under Confirmatory documents, still deficiency was observed by the TC, hence his offer had not been techno-commercially eligible and acceptable.

Under the facts and circumstances mentioned above, **as per Clause 14.2.E under Tender Evaluation of the NIT** the business in the name and Style of **M/s Pooja Electricals, Ward No. 17, Main Road, Chanwaridand ATA Chouk, Manendragarh – 497442, Chhattisgarh, Proprietor: Birendra Kumar Singh, Login ID: birendrakumarsinghmdgr@gmail.com, PAN No.: AVJPS2408N, GSTIN: 22AVJPS2408N1ZC**, is hereby banned for 02 (Two) years from being eligible to submit Bids in CIL and its subsidiaries with immediate effect.
