ORDER FOR BANNING OF BUSINESS

An NIT bearing no:- SDOCM/PE(EnM)/e.tender/21-22/ 06 dt.11.06.2021,Tender ID 2021\_ CCL\_208864\_4 for the work related "complete repairing full overhauling with spares of one kirlosker make SDOCM ,Dhori Area" was floated on CIL e- Procurement Portal.

After opening of price bid on schedule date & time **M/s Ramanand Singh and Co.** was found L-1 bidder. Moreover, technical Evaluation of documents uploaded by the LI bidder i.e **M/s Ramanand Singh and Co.** Was done as per NIT and some deficiency was requested online to upload required shortfall documents within in schedule time from 10.08.2021 at 03.00 P.M. to 18.08.2021 at 03.00 P.M. (09 Days) on e-portal of coal India limited as per clause no. 14.2.B of the e-NIT. **M/s Ramanand Singh and Co.** has not fulfilled the required shortfall documents within the schedule time period.

As per clause no. 14.2.E of the e-NIT which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected and the bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-procurement portal"

Under the facts and circumstances mentioned above, as per clause no. 14.2..B , C & E under Tender Evaluation of the NIT the business in the name and **M/s Ramanand Singh and Co.** Authorized Partner Niraj Kumar Singh , Address :- Naya Road, Block Colony, PO:- Phusro Bazar, Dist :- Bokaro (Jharkhand), Pin:- 829144 login PAN No:- AACFR1903K& GSTIN No:- 20AACFR1903K2ZN is hereby banned for 02 (Two) years from eligible to submit bid in CIL and its subsidiaries with immediate effect.
