**ORDER FOR BANNING OF BUSINESS**

An NIT bearing No. So(E&M)/e-tender/21-22/36 (S.No.5) dated 20/07/2021 , Tender ID- 2021\_CCL\_212370\_5 , for the Work titled "Comprehensive annual maintenance and servicing, running, repairing, replacement of damage component & maintenance of 90 Nos. split AC machine of different location (G.M. office Transit camp, G.M. Bungalow, Regional hospital Kargali, officer Club, Regional Store Jarandih & Jarandih Siding ) of G.M Unit, B&K Area.

After Opening of Price Bid on scheduled date & time, **V.K.Enterprises, Q.No. 1011, Sector-4 ,B.S.City, Bokaro Steel City, Jharkhand, 827004** was found L-3 bidder. After rejection of L-1 and L-2 Bidder and competent approval L3 has been consider L-1 for this tender. Moreover, Technical Evaluation of documents uploaded by L-3 Bidder, **V.K.Enterprises, Q.No. 1011, Sector-4 ,B.S.City, Bokaro Steel City, Jharkhand, 827004** , was done as per NIT and some deficiency was found by the T.C in the uploaded documents. Accordingly , **V.K.Enterprises**, was requested online to upload required shortfall documents. within in the schedule time from 23/10/2021 to 29/10/2021 on e-portal on coal India Limited as per Clause No. 14.2.B of the e-NIT. **V.K.Enterprises**, has not responded for the required shortfall documents within scheduled time period as per NIT.

As per clause 14.2.E of thee-NIT, Which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information /declaration furnished by the L-1 Bidder online is found to be wrong by tender committee during evaluation of scanned document uploaded by bidder which changes the eligibility status of the bidder, than his bid shall be rejected the bidder will be banned for (02)two years from being eligible to submit bids in CIL and its subsidiary from date of issue of this letter .This banding shall be done under the provision of NIT and online blocking all the bidders shall be done in CIL e-Procurement portal until the Portal."

Under the facts and circumstances mentioned above , as per clause 14.2.B,C & E under Tender Evaluation of the NIT the business in the name **V.K.Enterprises, Q.No. 1011, Sector-4 ,B.S.City, Bokaro Steel City, Jharkhand, 827004**, Login id. [v.k.enterprises1948@gmail.com](mailto:v.k.enterprises1948@gmail.com) , PAN No. AIOPS4825R , GST No. 20AIOPS4925R2ZJ is hereby banned for 02(two) year from being eligible to submit bid in CIL and its subsidiaries with immediate effect.
