An NIT bearing no:- S.O.(E&M)/M-Se-NIT/21-22/04 dated:- 01.05.2021 , Tender ID:- 2021_CCL_205326_1 for the work related "Supply, installation and commissioning of network IP based CCTV surveillance system at at newly established GM office of Magadh- Sanghmitra Area at Bachra under M-S Area" was floated on CIL e- Procurement Portal

After opening of price bid on schedule date & time Optimum Sale and service LLP, Bokaro was found L-1 bidder. Moreover, technical Evaluation of documents uploaded by the L-1 bidder i.e Optimum Sale and service LLP, Bokaro was done as per NIT and some deficiency was requested online to upload required shortfall documents within in schedule time from 19.06.2021 at 10.00 A.M. to 26.06.2021 at 05.00 P.M. (07 Days) on e-portal of coal India limited as per clause no. 14.2.B of the e-NIT. Optimum Sale and service LLP, Bokaro has not fulfilled the required shortfall documents within the schedule time period.

As per clause no. 14.2.E of the e-NIT which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected and the bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal"
