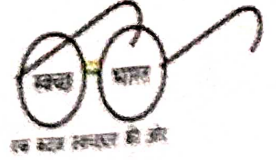

Subject > ORDER FOR BANNING OF BUSINESS

An NIT bearing no:- G.M.(M-S)/S.O.(E&M)/e-NIT/21-22/04 dated:- 29.05.2021, Tender ID:- 2021_CCL_207597_1 for the work related "Supply, installation and commissioning of single band GEAPON ONT with Wi-Fi, 1 GE, 1F AND 1 Voice port including required splitter, Patch cord, jointing box, splitter etc. under M-S Area" was floated on CIL e- Procurement Portal

After opening of price bid on schedule date & time M/s Mukesh Rana, Paroka Khurd, Tandwa was found L-2 bidder. The L-1 bidder i.e. M/s Ayub Ansari, Dakra has been rejected as per clause 14.2.H. Moreover, as per clause no. 14.2.G the technical Evaluation of documents uploaded by the original L-2 bidder now becomes L-1 Bidder i.e. M/s Mukesh Rana, Paroka Khurd, Tandwa was done as per NIT and some deficiency was requested online to upload required shortfall documents within in schedule time from 29.07.2021 at 10.00 A.M. to 05.08.2021 at 05.00 P.M. (07 Days) on e-portal of coal India limited as per clause no. 14.2.B of the e-NIT. M/s Mukesh Rana, Paroka Khurd, Tandwa has not fulfill the required shortfall documents within the schedule time period.

As per clause no. 14.2.E of the e-NIT which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected and **the bidder will be banned for 02 (Two) years from being eligible to submit bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal.**"

Under the facts and circumstances mentioned above, as per clause no. 14.2.B, C & E under Tender Evaluation of the NIT the business in the name and M/s Mukesh Rana, Paroka Khurd, Tandwa, Proprietor:- Mukesh Rana, Address > At- Paroka Khurd, P.O.- Tandwa, Distt- Chatra, 825408 login Id:- Nil, PAN No:- BFFPR0822C & GSTIN No:- Nil, is hereby banned for 02 (Two) years from eligible to submit bid in CIL and its subsidiaries with immediate effect.
