Consequent to the termination of contract with ECIL (Electronics Corporation of India Ltd.) w.e.f 06/06/2021 vide ref no. GM(Sys.)/2021-22/103/D dated 05/06/2021, the following penalty as per clause 10.2 of General Terms & Conditions (GTC) of NIT/workorder/Agreement is being imposed on ECIL for compliance.


1. Deposition of Rs. 62,64,185.91 including GST (i.e. 20% of the value of incomplete work of value Rs. 3,13,20,929.53 including GST) as penalty as per clause 10.2 of GTC of the Agreement within 30 days from issue of this letter.

If, ECIL fails to deposit the penalty amount as mentioned above within the stipulated time period indicated above, CCL will recover the amount as per clause 10.2 of GTC of the Agreement.

2. ECIL shall not be allowed to participate in future bidding in CCL for a period of Twelve (12) months from the date of issue of this letter.


