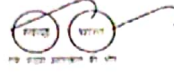

ORDER OF BANNING OF BUSINESS

One NIT bearing no. GM(K)/EnM/eTender/20-21/94, Dated:- 23.06.2020. Tender ID:- 2020_CCL_175803_1 for the work of "Complete rewinding, repairing & installation of 1 MVA, 11 KV/3.3 KV of Ara Project under Kuju Area" was floated.

After been found techno commercially eligible, offer of M/S Central Engineers , Main Road Singrauli Dist. Madhya Pradesh for Complete rewinding, repairing & installation of 1 MVA, 11 KV/3.3 KV of Ara Project under Kuju Area was accepted & work order issued vide letter no. GM(K)/E&M/WO/2020/187 , Dated :- 03.09.2020. After that the Transformer was handed over to you vide Gate pass no. EE0040789 on 23.11.2020.

After a lapsed of stipulated period, reminder on frequent intervals were sent to him but still transformer was not delivered. Details of the reminders are enumerated below.

In view of the above following action against said firm for the negligence of work order as well disobey the direction of the office as per norms of the company as well as T&C of the NIT already accepted by the firm & applicable to him are hereby taken.

1. The work order issued to M/S Central Engineers , Main Road Singrauli Dist. Madhya Pradesh vide no. GM(K)/E&M/WO/2020/187 , Dated :- 03.09.2020 is hereby stand cancelled.
2. The security money, EMD, Additional Security etc deposited by him for the job is hereby forfeited.
3. The business in the name and style M/S Central Engineers, Pan no. AAC PQ2197C either in proprietorship or in partnership is hereby banned for participating in the future tenders of CCL for a minimum period of twelve months.
