### **ORDER FOR BANNING OF BUSINESS**


An Ambulance bearing Reg. No.JH-01ED-6072 was provided by M/s Chandra Bhushan Prasad, At : Near Shiv Mandir, A type Colony, Dakra Post: Dakra, Dist: Ranchi – 829210, Mob: 7870011793, 9162180761 on hired basis against the tender Notice vide No. SO(EnM)/PPR/e-NIT/20-21/34; Dated: 15.09.2020, Tender ID: No.2020\_CCL\_182708\_1 and Award of Work vide No.SO(E&M)/PPR/Award/NL/20-21/1375-80 dtd.03.12.2020 for a period of 5 years from 01.12.2020 to 30.11.2025 for Regional Hospital, Piparwar Area.

The above said ambulance was met with an accident on 17-04-2021. In spite of giving several letter and requested over telephone for providing Ambulance, Neither the repaired ambulance nor any replacement of this ambulance has been provided by M/s **Chandra Bhushan Prasad till date**. In the meantime, the outbreak and severity of COVID – 19 pandemic has worsened and the running of existing ambulances for carriage of serious patients to Central hospital, Gandhi nagar / Naisarai and other locations has become very frequent and causing exhaustion of sanctioned diesel limits. So, the un-availability of this ambulance with registration no. JH-01-ED-6072 has created an emergency situation and creating IR problems.

**As per clause no. 9 of Special conditions of contract "If the hired vehicle remains under breakdown for more than 10 days in a month and at a suitable replacement is not given, the contract will be terminated and the security money deposited with the Management will be forfeited."**

Additionally, the company shall debar such defaulting contractor M/s Chandra Bhushan Prasad, Address : Near Shiv Mandir, A type Colony, Dakra Post: Dakra, Dist: Ranchi – 829210, login id:-akdpp7602g@gmail.com, PAN:- AKDPP7602G & GSTIN:- 20AKDPP7602G1ZK is hereby banned for 01 (one) year from being eligible to submit bid in CCL with immediate effect.
