ORDER FOR BANNING OF BUSINESS

An NIT bearing no. SO(EnM)/PPR/e-NIT/20-21/168; Dated: 18.03.2021, Tender ID: 2021_CCL_202381_1 for the work titled "(A) Dismantling of 3 ranges, 1100 Mtr length each 8" dia pipeline from Quarry 2 to Quarry 1 Piparwar patch (B) Laying of 02 ranges of 8" dia pipeline each of approx. length 1350 Mtr from sump at Quarry No. 2 to Mangardaha Nalla under Ashok OCP, Piparwar Area." was floated on CIL e-Procurement Portal.

After opening of price bid on scheduled date & time. M/s Shyam Construction, Dakra, Ranchi, Jharkhand - 829210 was found L-1 bidder. Moreover, Technical Evaluation of documents uploaded by L-1 bidder i.e. M/s Shyam Construction was done as per NIT and some deficiency was found by TC in the uploaded documents. Accordingly, M/s Shyam Construction was requested online to upload required shortfall documents within in scheduled time from 13.04.2021 AT 11.00 AM to 20.04.2021 AT 11.00 AM (07 days) on e-portal of Coal India Limited as per clause no. 14.2.B of the e-NIT. M/s Shyam Construction has not uploaded the required shortfall documents with in scheduled time period.

As per clause 14.2.E of the e-NIT, which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected the bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal."

Under the facts and circumstances mentioned above, as per clause 14.2.B, C & E under Tender Evaluation of the NIT the business in the name and style M/s Shyam Construction, Proprieter: - Shyam deo mahto, Adress: - Dakra, Ranchi, Jharkhand - 829210, login id:- santoshlovesantosh@gmail.com, PAN:- ACNPM4641E & GSTIN:- 20ACNPM4641E1ZX is hereby banned for 02 (Two) years from being eligible to submit bid in CIL and its subsidiaries with immediate effect.
