ORDER FOR BANNING OF BUSINESS

An NIT bearing no. SO(EnM)/PPR/e-NIT/20-21/97; Dated: 02.01.2021, Tender ID: 2021_CCL_192113_1 for the work titled "Repairing and maintenance of 11 KV, 440 V O/H line, light fittings, transformer etc. installed at Garhi filter plant, Bachra siding, Kalyanpur coal dump, Rehabilitation center under CHP-CPP for a period of 01 year" was floated on CIL e-Procurement Portal.

After opening of price bid on scheduled date & time, M/s Pooja Construction, Dakra, Khalari, Ranchi, Jharkhand - 829209 was found L-1 bidder during the tender proceeding. Moreover, Technical Evaluation of documents uploaded by L-1 bidder i.e. M/s Pooja Construction was done as per NIT and some deficiency was found by TC in the uploaded documents. Accordingly, M/s Pooja Construction was requested online to upload required shortfall documents within in scheduled time from 04.03.2021 AT 10.00 AM to 11.03.2021 AT 10.00 AM (07 days) on e-portal of Coal India Limited as per clause no. 14.2.B of the e-NIT. M/s Pooja Construction has not uploaded the required shortfall documents with in scheduled time period.

As per clause 14.2.E of the e-NIT, which states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected the bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal."

Under the facts and circumstances mentioned above, as per clause 14.2.B, C & E under Tender Evaluation of the NIT the business in the name and style M/s Pooja Construction, Proprieter: - Surendra Singh, Address: - Dakra, Khalari, Ranchi, Jharkhand - 829209, login id: - singhsurendar1975@gmail.com, PAN:- APOPS0664K & GSTIN:- 20APOPS0664K1ZN is hereby banned for 02 (Two) years from being eligible to submit bid in CIL and its subsidiaries with immediate effect.
