Subject: Banning/delisting of future Business dealings of M/s Galaxeos RN Singh JV and both the partners of JV from participating in future tenders for a period of 02 (two) years with Central Coalfields Limited (CCL).

Dear Sir.

- 1. In reference to the above referred e-tender, M/s Galaxeos RN Singh (JV) had submitted tender on dated 26.11.2020 in the e-procurement portal of Coal India Limited.
- 2. The bid was opened on dated 28.11.2020 at 11:00 hrs (Part-I) and price bid/Part-II) was opened on dated 18.01.2021 at 11:00 hrs in which M/s Galaxeos RN Singh JV has been declared L1 by the System.
- 3. After opening of the price bid on dated18.01.2021 (same day) at 03:37 PM a mail has been received through the mail of the Sr. Manager(I/c), FSNL, Burnpur, stating-

"As per your letter ref. no. GM(KTA)/SO(M)/Tender/2020/566/34 dated 06.01.2020. The letter was perused and it was found that the work completion certificate was issued by the Executive, who is not authorized to issue such certificates.

Hence, the certificate may be treated as withdrawn.

This is for your kind information please".

4. We/CCL Management has tried our best, to verify from the FSNL, the documents submitted by M/s Galaxeos RN Singh JV i.e., the work experience certificate issued in the name of M/s RN Singh & Co. (Partner of Galaxeos RN Singh JV) and for clarification regarding genuineness of the documents as submitted in the Bid Submission sheet.

Accordingly different mails and letters by Speed Post were sent to the concerned Officers of FSNL, Burnpur Unit and also to the Officers concerned at Head Office, Bhilai.

No reply was made to any of the above correspondence made with concerned FSNL authorities.

In view of the above and in light of Clause no. 16.2(vi) of Chapter-I of 'Guidelines for e-Procurement of works and services', the provision of Letter of Bid, clause no.3.4 of ITB (Instruction to Bidders), E-tender portal User Agreement, Undertaking in tender document 8(h) corresponding to e-tender Notice no. **[clause** no. of NIT], GM(KTA)/SO(M)/Tender/2020/566 Date:10.11.2020 (Tender Id-2020 CCL 186735 1), floated in the e-procurement portal of Coal India for the work of "Loading of Coal by Contractors pay-loader at Jarangdih OC Surface Stock Heap no.6 & 8A into Contractors tipping trucks and transportation to Jarangdih Feeder Crusher after weighment at Jarangdih Weighbridge (both end) & unloading mechanically at Jarangdih Colliery, Period-12 months (365 days), Quantity-5.50 Lakh Te for distance slab 1-2 KM", competent authority of CCL has decided to take penal actions against M/s Galaxeos RN Singh JV and both the partners i.e., M/s R.N. Singh & Co. and M/s Galaxeos Infratech on the ground of "Willful suppression of facts or furnishing or wrong information or manipulated or forged documents by the Agency or using any other illegal/unfair means" thereby imposed following Penalties against you:

- (a) Forfeiture of EMD(Earnest Money Deposit) for Rs.2,51,000/- against the above said e-tender deposited by M/s Galaxeos RN Singh JV.
- (b) Banning of the following firms/individuals for future business dealings including participation in future tenders with CCL for a period of 02 (two) years from the date of Issue of this Banning letter/Notice:-
 - (i) M/s Galaxeos RN Singh JV (Address-At-Gomia Gurudih, PO-Gomia, Bokaro, Jharkhand-829111),

- (ii) M/s R.N. Singh & Co. (Address- At-B-1, City Centre, Sector-4, Bokaro Steel City-827004), PAN No.- AADFR6017M.
- (iii) M/s Galaxeos Infratech (Address- Vill-Palihari Gurudih, PS:Gomia, Gomia, Bokaro Jharkhand), PAN No.- AAVFG2609Q.
