ORDER FOR BANNING OF BUSINESS

One NIT bearing no GM(Ra)/EnM/e-NIT/L.Veh.Hire/19-20/06 Dated 08.08.2019 , Tender ID: 2019_CCL_146903_1 for the work of hiring of 05 no. hard top closed door type diesel jeep on daily hire basis (24hrs service) for a period of 03 years to be deployed under Rajhara Area (Chandwa) was floated.

After been found techno- commercially eligible, offer of M/s- Md. Afsar Alam , At-Murpa, PO-Balumath, PS-Balumath, Dist -Latehar 829202 for providing of one no. hard top closed door diesel jeep (Regd. No. JH-01DW-2634 for three years on 24 hrs./day running basis for deployment at GM Unit Rajhara Area. Was accepted & Work Order issued vide letter No. GM(RA) Chandwa/19-20/Hiring of Jeep/E&M/WO/195 dated 21.03.2020.

After a lapsed of stipulated period reminder on frequent intervals were sent to him as well as many of times it was tried to contact him over his mobile number, but no response/communication was received from his side .

- The security money –EMD Deposited by him for the job at the time of bidding i.e. Rs.16240.00 (Rupees sixteen thousand two hundred forty) Ref PRN NO. 151463437292. Bank/UTR NO.53901058) only and also security deposit Rs. 771.00(seven hundred seventy one) DD NO. 000030 Dated 01.07.2020 is hereby forfeited.
- The business in the name and style of M/s Md. Afsar alam, Pan No. DKJPA2129G either in proprietorship or in partnership is hereby banned for participating in the future tenders of CCL for a minimum period of twelve months.
