Kindly refer to above referred e-tender notice for "Hiring of 01 no. Diesel driven closed Jeep on 24 hrs. engagement basis including supply of diesel by the contractor for a period of three years (1095 days) attached to Security Department for deployment under the control of Project Officer, Urimari Project."

After opening of Price bid, committee found that M/S SAI CONSTRUCTION, Proprietor- Basu Prajapati, At- CIC Basti, P.O.- Barkakana, Distt.- Ramgarh (Jharkhand) has quoted L-1 offer for the aforesaid job. You were asked to submit shortfall confirmatory documents online within 07 days. You did not submit requisite documents online as per NIT.

Clause no. 14.E under heading Tender evaluation of NIT states that "In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/ declarations furnished by the L-1 bidder is found to be wrong by the Tender Committee during evaluation of scanned documents uploaded by the bidder, which changes the eligibility status of the bidder, then the bid shall be rejected and the bidder will be banned for (02) two years from being eligible to submit Bids in CIL and its subsidiaries from date of issue of such letter. This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal."
