**Subject:** Regarding banning from participation in future tenders of Coal India Limited and its subsidiaries for a period of two years from the date of issue of this letter viz 24.11.2021 for having failed to furnish "partnership deed" in respect of NIT no. GM (KTA)/SO(C)/E-tender/2021-22/347 dt 02.07.2021 Tender ID:2021\_CCL\_210865\_1 for the work "Hiring of consultancy services for preparation of preliminary and detailed estimate, detailed working drawing and preparation of structural design for the work construction of pavilion, gallery and sports complex at Area Football Ground, Kathara Area."


Dear Sir,

This is to inform you that you had furnished your bid with BID ID no 688635 in respect of NIT no. GM (KTA)/SO(C)/E-tender/2021-22/347 dt 02.07.2021 Tender ID:2021\_CCL\_210865\_1 for the work "Hiring of consultancy services for preparation of preliminary and detailed estimate, detailed working drawing and preparation of structural design for the work construction of pavilion, gallery and sports complex at Area Football Ground, Kathara Area." and your bid was found lowest, that is, L1.

Accordingly, Tender evaluation was done as per stipulations under clause 13 of the NIT (copy of clause 13 enclosed). The documents uploaded by you under this NIT were downloaded and examined by the Tender committee. (as per clause 13 Tender Evaluation, sub clause a.)

The tender committee observed that you (the L1 bidder, namely Sushumna Consultancy Services LLP) declared yourselves as partnership firm in the bid submission confirmation sheet but did not furnish Partnership deed or LLP agreement, the corresponding document required to confirm your legal status.

As per NIT, No recycling is permitted in respect of legal status as it is required under the bidder's space (i.e. asking of shortfall clarification is not permitted).



For clarity, NIT provisions regarding eligibility criteria with respect to legal status are reproduced from clause "4. Eligibility Criteria" of the NIT:

**Quote:**

"Scanned copy of documents to be uploaded by bidders (BIDDER SPACE/ MY DOCUMENT);

Moreover, the following documents shall be considered from the Bidder's space/ My Document and no recycling will be done for these documents i.e. no further clarification will be sought from bidder –

In view of the above, the TC concluded that you, (the L1 bidder) clearly failed to submit legal status i.e partnership deed or LLP Agreement.

**Because you ( the L1 bidder) failed to submit requisite documents online as per NIT, action as per clause 13e of the NIT has been approved by the competent authority against you.**

Clause 13 e of the NIT is reproduced below for your ready reference:

**Quote:**

"13. Tender Evaluation (e): In case the L-1 bidder fails to submit requisite documents online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by Tender Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected and the bidder will be banned for two years from being eligible to submit Bids in CIL and its subsidiaries.

This banning shall be done under the provisions of the NIT and online blocking of the bidder shall be done in CIL e-Procurement portal."

In view of the above, this is to inform you that

i) Your bid for the subject work "Hiring of consultancy services for preparation of preliminary and detailed estimate, detailed working drawing and preparation of structural design for the work construction of pavilion, gallery and sports complex at Area Football Ground, Kathara Area" has been rejected

and

ii) You, M/s Sushumna Consultancy Services LLP, along with your designated partners namely Vivek Kumar Pankaj and Jyoti Gupta, are hereby banned for a period of two years from being eligible to submit Bids in CIL and its subsidiary with effect from 24.11.2021 (the date of issue of this letter).
