GM (KTA)/SO(C)/E-tender/2020-21/2407 dt 18.04.2021 Tender ID:2021_CCL_193917_1 for the work "Drilling/construction of one no bore hole for installation of Peizometer at pit office, Kathara colliery, Kathara Area."

Dear Sir,

This is to inform you that you had furnished your bid with BID ID no 607306 in respect of NIT no. . GM (KTA)/SO(C)/E-tender/2020-21/2407 dt 18.04.2021 Tender ID:2021_CCL_193917_1 in the e-procurement Portal of Coal India Limited (https://coalindiatenders.nic.in) for the work "Drilling/construction of one no bore hole for installation of Peizometer at pit office, Kathara colliery, Kathara Area" and your bid was found lowest, that is, L1.

Accordingly, Tender evaluation was done as per stipulations under clause 13. Of the NIT (copy of clause 13 enclosed). The documents uploaded by you under this NIT were downloaded and examined by the Tender committee. (as per clause 13 Tender Evaluation, sub clause a.)

The tender committee found deficiency in the uploaded document CA Certificate regarding GST unregistered bidder submitted by you and recommended for specifying the same online. Accordingly, the same (the shortfall clarification) was specified online with Document submission start date: 24.03.2021 at Hours:13 mins:00 and Document submission Closing date: 31.03.2021 up-to Hours:13 mins:00

Confirmatory Documents Requisition" read

"In the CA certificate regarding GST status no UDIN and date of issuing is mentioned. Hence bidder is required to clarify this and submit CA certificate regarding GST status with UDIN. This is required as shortfall/clarification document. This is required as shortfall/Clarification document."

In response you submitted a revised CA certificate regarding unregistered bidder as shortfall document. Tender committee examined the shortfall document submitted by you and the following was observed & recommended as "In the CA certificate it is mentioned that turnover of Shyam Kumar is below threshold limit of 40 Lakh so bidder is exempted from getting registration. But as per GST law for service & works tender the threshold limited exemption from GST is Rs.20 Lakh. Hence the submitted certificate is not as per GST law. Hence TC recommend to cancel bid of

Shyam Kumar also recommend to bank Shyam Kumar for two years from being eligible to submit bid in CIL & its subsidiaries."

As you failed to submit requisite documents online as per NIT. Action as per NIT Clause 13e has been approved by the Competent authority i.e. to reject your bid and to ban you (PAN No BGHPK2150F), this is to inform you that

i) Your bid for the subject work has been rejected and

ii) You are hereby banned for a period of two years from being eligible to submit Bids in CIL and its subsidiary with effect from 27.11.2021 (the date of issue of this letter).

The Price Bid of the tenderers will have no condition. The price bid which is incomplete and not submitted as per instruction given in this document is liable for rejection.

System for decision of L1 bidder

The L1 bidder will be decided based on Overall Quoted Value (i.e. cost to the Company). The system for decision of L1 bidder will be as per following 02(two) cases:-

Case - 1: Supply for which INPUT TAX CREDIT (ITC) is not available to the Company.

For calculation of Overall Bid Value, the GST [CGST, SGST/UTGST, IGST and GST (compensation to state tax)] to be paid by the bidder or by CIL/ Subsidiary taken by the system will be <u>added</u> to decide the L1 i.e the ranking of the Bidders will be decided based on rates quoted by the bidders plus GST. This value of the bidder will be "the Cost to Company".

Then share of GST to be deposited by CIL/ Subsidiary, if any will be <u>deducted</u> from overall bid value to arrive at the Contract value. The Price-bids of the tenderers shall have no condition. The Price Bid which is incomplete and not submitted as per instruction given above is liable for rejection.

Case - 2: Supply for which INPUT TAX CREDIT (ITC) is available to the Company.

For calculation of Overall Bid Value, the GST [CGST, SGST/UTGST, IGST and GST (compensation to state tax)] to be paid by the Bidder or by CIL/ Subsidiary taken by the system will be <u>ignored</u> to decide the L1 i.e the ranking of the Bidders will be decided based on rates quoted by the bidders excluding GST. This value of the bidder will be "the cost to Company".

Then share of GST to be paid by bidder shall be <u>added</u> with overall bid value to arrive at the Contract value. The Price-bids of the tenderers shall have no condition. The Price Bid which is incomplete and not submitted as per instruction given above is liable for rejection.

Note: The bidder should select their GST category as per clause no. 8.B of NIT.

10. Bid Submission

All bids are to be submitted on-line on the website https://coalindiatenders.nic.in. No bid shall be accepted off-line unless otherwise specified.

11. System Requirement

It is the bidder's responsibility to comply with the system requirement i.e. hardware, software and internet connectivity at bidder's premises to access the e-tender website. Under any circumstances, CIL/ Subsidiary shall not be liable to the bidders for any direct/indirect loss or damages incurred by them arising out of incorrect use of the e-tender system or internet connectivity failures.

12. Opening of Bid

Tender will be decrypted and opened online by the "Bid Openers" with their Digital Signature Certificates on/after the prescheduled date & time of Tender Opening.

13. Tender Evaluation

After opening of bid, the documents submitted by L-1 bidder in cover I as enlisted in the NIT will be downloaded by the Evaluator and shall be put up to the Tender Committee. The tender Committee will examine the uploaded documents against information/declarations furnished by the L1 bidder online. If it confirms to all of the information/declarations furnished by the bidder online and does not change the eligibility status of the bidder then the bidder will be considered eligible for award of Contract.

In case the Tender Committee finds that there is some deficiency in uploaded documents corresponding to the information furnished online or in case corresponding document have not been uploaded by L-1 bidder then the same will be specified online by Evaluator clearly indicating the omissions/shortcomings in the uploaded documents and indicating start date and end date allowing 7 days (7 x 24 hours) time for online re-submission by L-1 bidder. The L-1 bidder will get this information on his personalized dashboard under "Upload confirmatory document" link. Additionally, information shall also be sent by system generated email and SMS, but it will be the bidder's responsibility to check the updated status/information on their personalized dash board regularly after opening of bid. No separate communication will be required in this regard. Non-receipt of e- mail and SMS will not be accepted as a reason of non-submission of documents within prescribed time. The L-1 bidder will upload the scanned copy of all those specified documents in support of the information/
