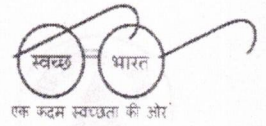

ORDER FOR BANNING OF BUSINESS

An NIT bearing No. SO(EnM)/PPR/e-NIT/20-21/110; Dated: 28.01.2021, Tender ID: 2021_CCL_194860_1 for the work titled "Walkway / Garden light in CISF Camp Bachra under GM Unit, Piparwar Area." was floated on CIL e-Procurement Portal.

After opening of price bid on scheduled date & time, M/s Trishul Construction and Company, Behind dispensary, KDH Colony, B Type Dakra Colliery, Ranchi, Jharkhand - 829210 emerged as L-1 bidder. This firm was found techno-commercially and financially eligible by the Tender Committee. TC also observed that the Electrical contractor's license submitted by L-1 bidder has been issued from the licensing board of Bihar state government.

TC recommended for approval to award the work to the L-1 party M/s Trishul Construction and Company with the condition that the bidder will have to submit electrical contractor's license (before execution of work) from Jharkhand Licensing Board for working in the state of Jharkhand as per clause no. 7.7 of NIT. The same was approved by the competent authority and a Letter of acceptance vide no. SO(E&M)/PPR/LOA/21-22/103-06; dated: - 26-07-2021 was issued to the L-1 firm i.e. M/s Trishul Construction and Company.

The party (M/s Trishul Construction and Company) was advised to deposit Performance Security of an amount ₹ 5000.00/- and submit the electrical contractor's license from Jharkhand Licensing Board for working in the state of Jharkhand within 21 days i.e. till 16-08-2021 of issuance of Letter of Acceptance for issuance of detailed work order before execution of work.

The L-1 Firm, M/s Trishul Construction and Company has submitted the Performance security money on 02-09-2021 i.e. after the due date of 16-08-2021 and has failed to submit the electrical contractor's license from Jharkhand Licensing Board for working in the state of Jharkhand within the scheduled time of 21 days from issuance of LOA. Hence, it has become non- eligible for award of work.

Under the facts and circumstances mentioned above and as per the provisions of Letter of bid, Bid Securing Declaration and Clause No. 14.2.E of the concerned e-NIT; **the Letter of Acceptance (LOA) No. SO(E&M)/PPR/LOA/21-22/103-06; dated: - 26-07-2021 is hereby cancelled and the business in the name and style M/s Trishul Construction and Company, Proprietor: - Nirantar Kumar Singh, Adress: - Behind dispensary, KDH Colony, B Type Dakra Colliery, Ranchi, Jharkhand - 829210, login id:- nirantarsingh83@gmail.com, PAN:- ANTPS0147A & GSTIN:- 20ANTPS0147A2ZC is hereby banned for 02 (Two) years from being eligible to submit bid in CIL and its subsidiaries with immediate effect.**
