You emerged as L1 bidder in the subject tender with quoted price of ₹77,21,826.78 (Including GST). It was observed that your quoted rate was 67.10 % below estimated cost with GST i.e. ₹2,34,73,278.00. In pursuant to the same, vide letter no. GM(E&M)/e-Tender/21/3179(H) dated 30.11.2021, you were asked to produce detailed price analysis for all items of the Bill of Quantity. In response to the same, you submitted a reply vide letter no. SUPL/CCL/2021-22/D. Spt-01 dated 04.12.2021.

Again, a letter was sent to you vide no. GM(E&M)/e-Tender/21/3269(H) dated 08.12.2021, requesting you to confirm whether you agree to execute the said work at Quoted Amount of ₹ 77,21,826.78 only. Another response was received from you vide letter no. SUPL/CCL/2021-22/D.431 dated 13.12.2021, informing that you have quoted the rates for each singular unit i.e. per meter, per job, per kg, per cum, per lot, per ton, per set etc. & your total cost comes to ₹ 2,20,00,143 20 only.

It is to inform you that as per Point no. 6 of Proforma of Undertaking as per Annexure-II of the NIT, you have unconditionally accepted following in GTE:
